Investment Objective

The Fund is suitable for investors:

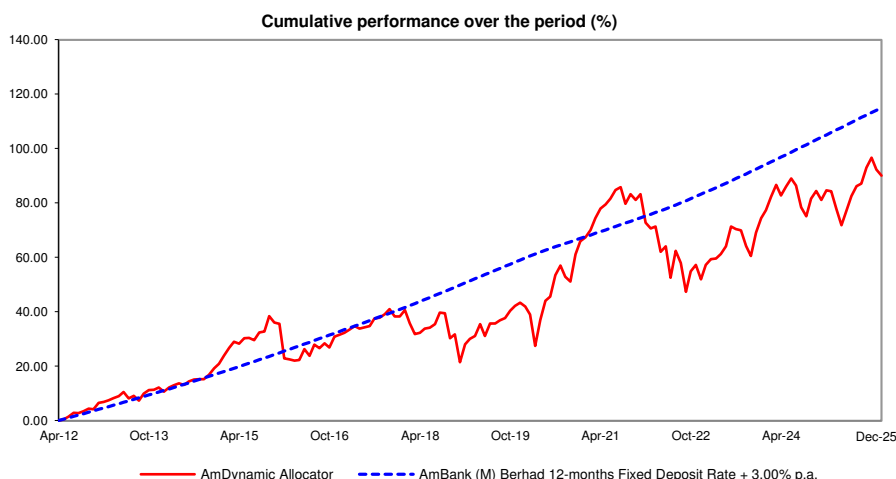
- seeking potential capital growth with yearly income*;

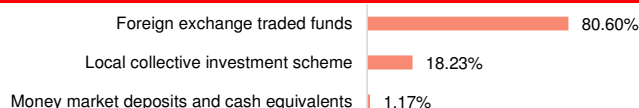

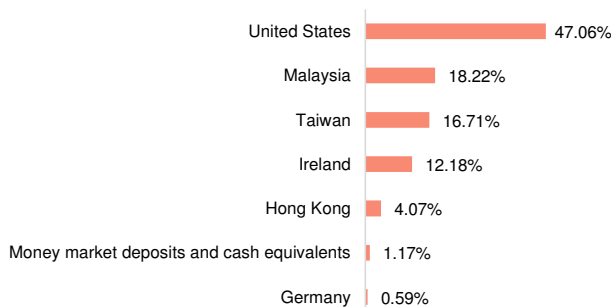
