- with short or medium-term**** investment goals.

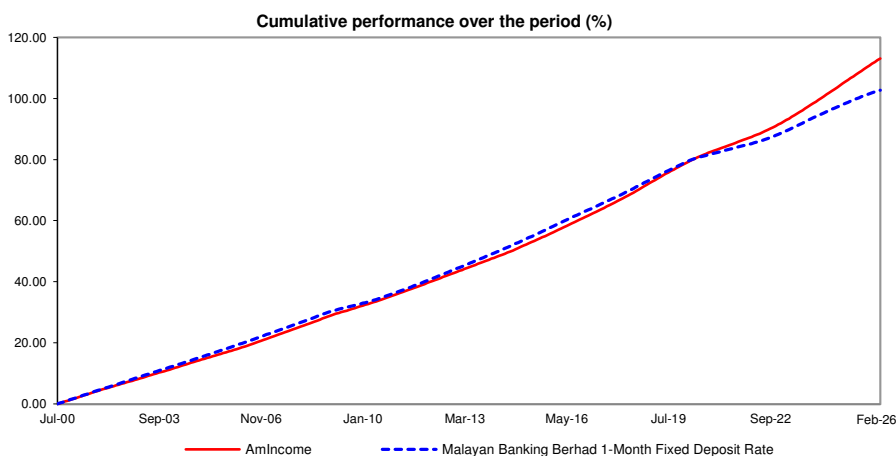

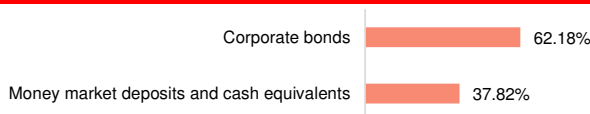

Asset Allocation (as at 28 February 2026)



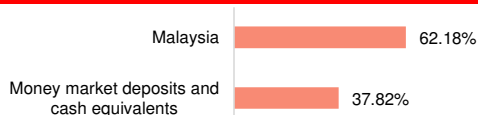
