Investment Objective

Amlslamic Balanced (the "Fund") aims to grow the value of investments in the longer term with lower volatility through asset diversification, which conforms to principles of Shariah.

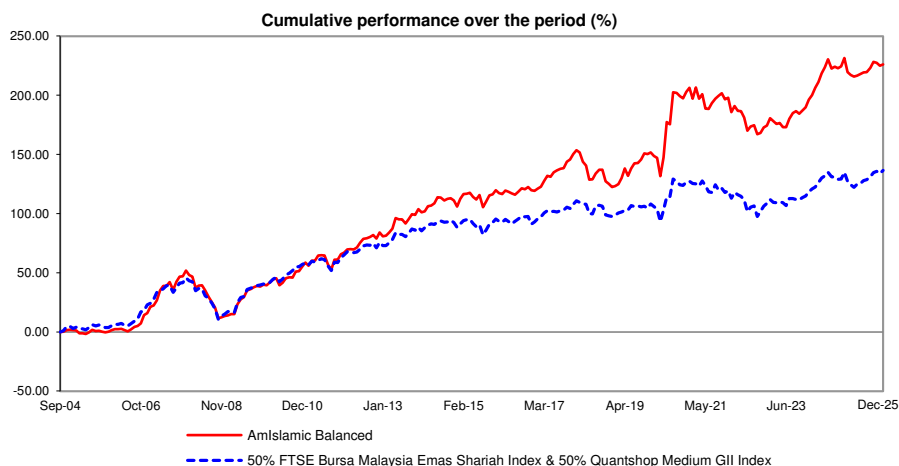
The Fund is suitable for investors:

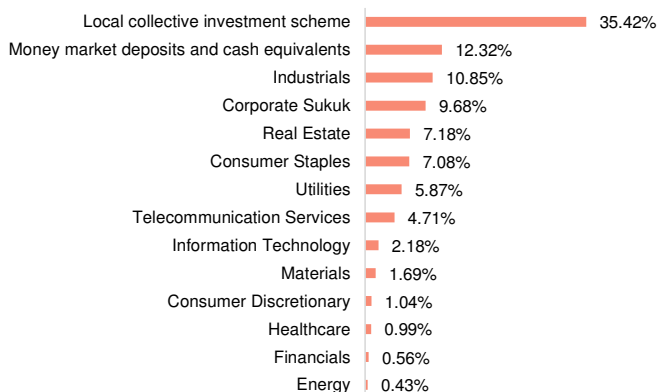

Sector Allocation (as at 31 December 2025)



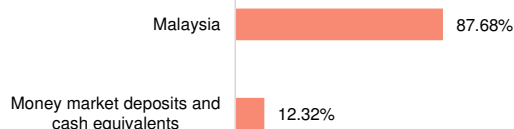
