Investment Objective

Amlslamic Cash Management - Class B (the "Fund") aims to provide regular stream of monthly income* and liquidity** by investing primarily in Islamic deposits and Islamic money market instruments.

The Fund is suitable for investors seeking:

- to invest excess cash over the short term;
- a Shariah-compliant investment that provides regular stream of income*; and
- access to liquidity** by the next day

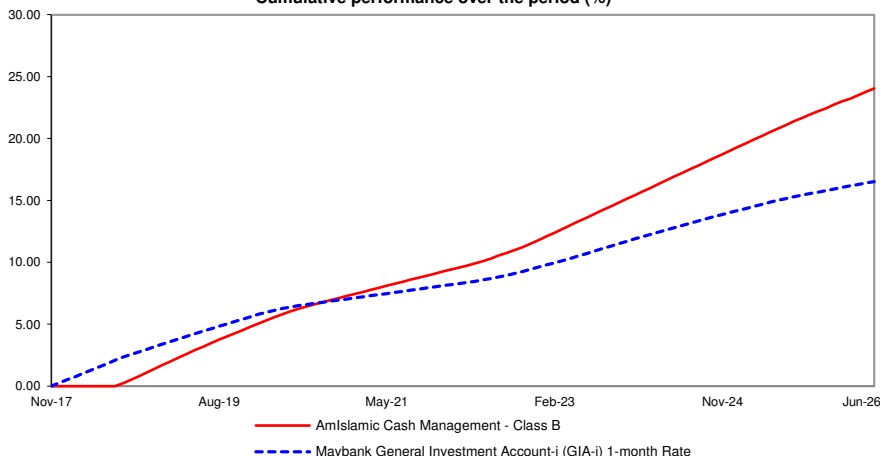
Notes: *Income distribution (if any) could be in the form of units or cash.

**Liquidity means that investors may receive their redemption proceeds on the next day after redemption application is received by the Manager on or before the cut-off time.
