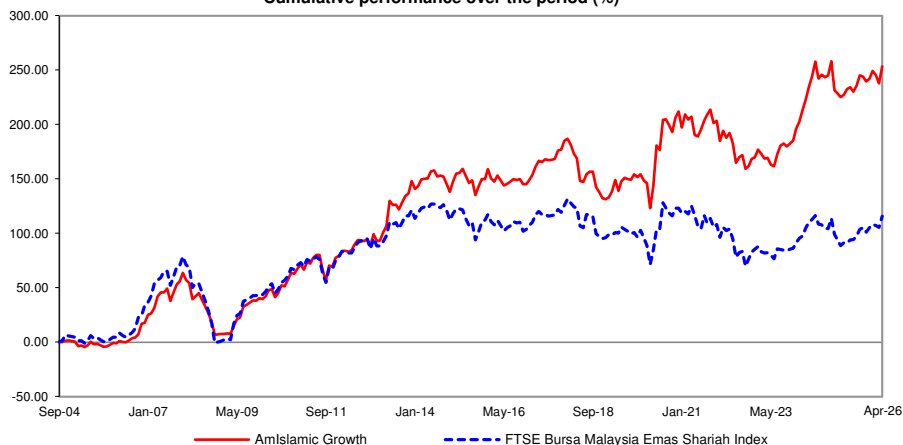

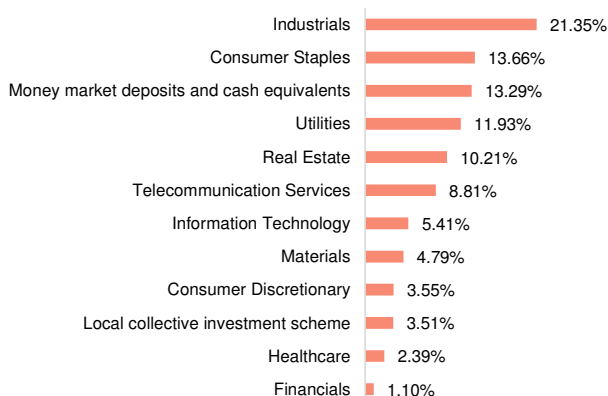

**Sector Allocation (as at 30 April 2026)**



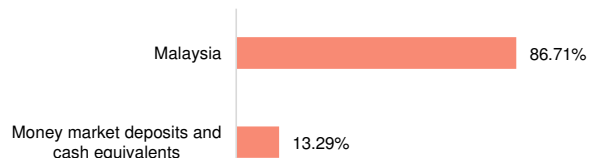
