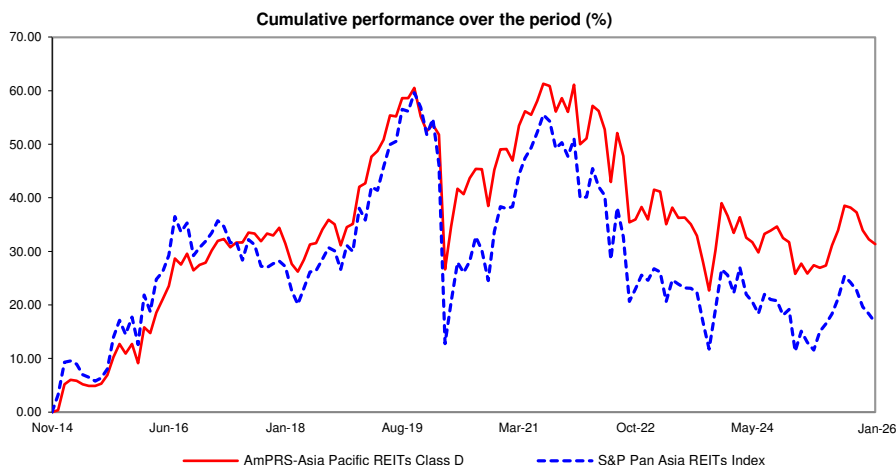
The Fund is suitable for Members seeking:

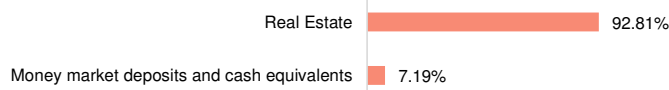

Sector Allocation (as at 31 January 2026)



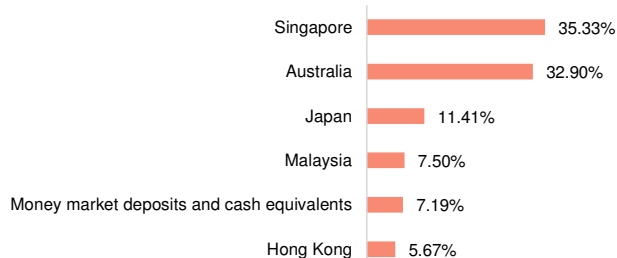

PRS Provider's Commentary (as at 31 January 2026)

Asian REIT markets recorded mixed performance in January 2026. While the U.S. Federal Reserve maintained its policy rates, expectations surrounding the potential appointment of Kevin Warsh—widely perceived as more hawkish—as the next Federal Reserve Chair weighed on overall investor sentiment toward REITs. In this environment, Singapore REITs ("S-REITs") posted a modest gain of 0.7% over the month. In contrast, Japanese REITs ("J-REITs") declined by 1.7%, reflecting upward pressure on long-term interest rates. Australian REITs ("A-REITs") extended their weakness, falling by 2.7%.
