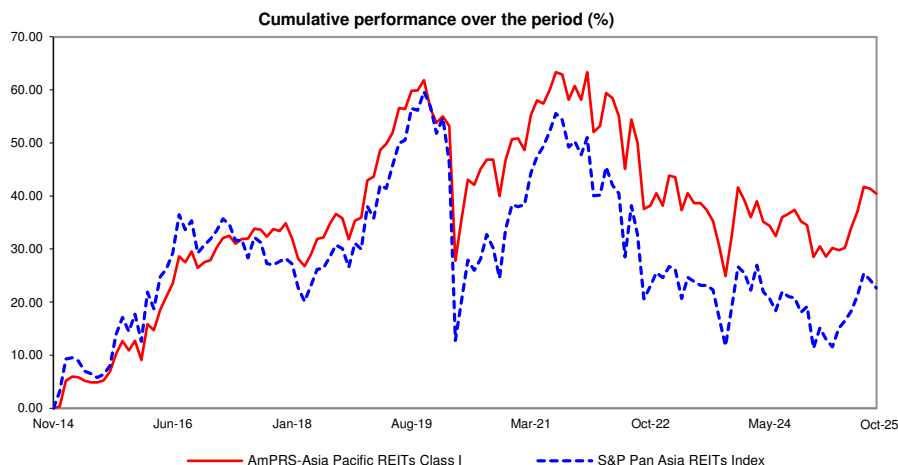
The Fund is suitable for Members seeking:

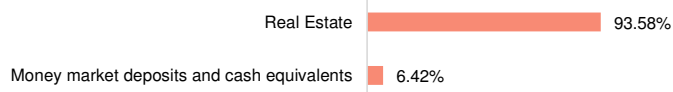

Sector Allocation (as at 31 October 2025)



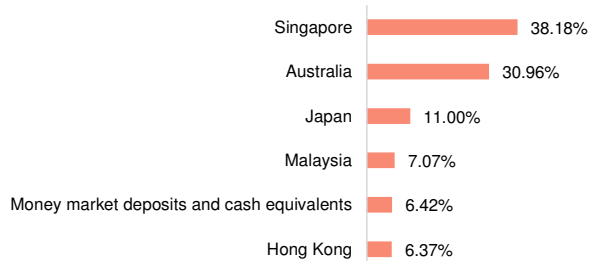

PRS Provider's Commentary (as at 31 October 2025)

Asian REITs recorded modest gains in October 2025. However, performance was mixed across the region and sectors. Singapore REITs led the region driven by office segment, which is a big beneficiary of a drop-in interest rate. Japan REITs also performed well, supported by robust leasing demand, low vacancy rates and inflation-linked rent hikes. In contrast, Hong Kong and Australia lagged the region, with the latter affected by higher inflation than expected and hence hopes of another rate cut by RBA in the near term faded.
