The Fund is suitable for Members seeking:

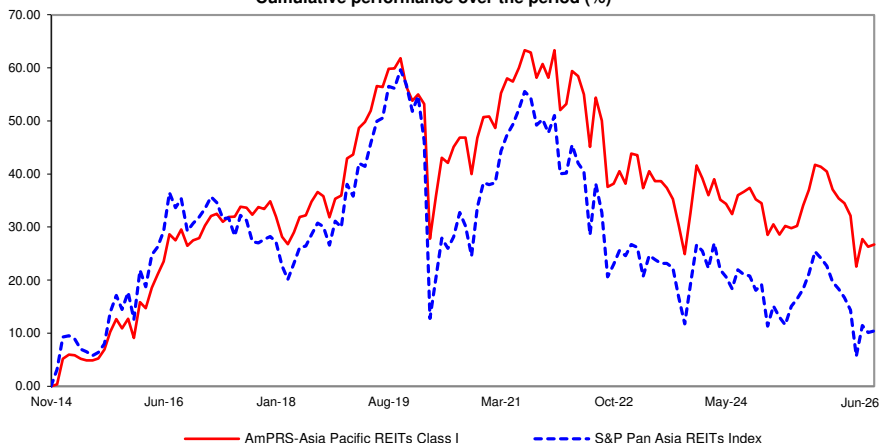
- an investment exposure through a diversified portfolio of REITs in Asia Pacific region; and

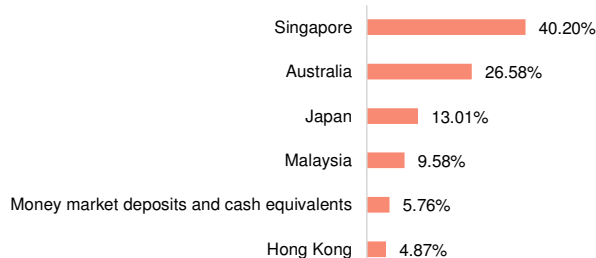

PRS Provider's Commentary (as at 30 June 2026)

Asian REIT markets delivered mixed performance in June 2026. Australian REITs (A-REITs) outperformed with a 1.7% gain, led by diversified and retail REITs. Singapore REITs (S-REITs) rose 0.4%, recovering toward month-end after early weakness caused by concerns over Middle East tensions, inflation and the risk of higher-for-longer US interest rates. Japanese REITs (J-REITs) declined 0.2%, as rising long-term interest rates and the Bank of Japan's policy rate hike continued to weigh on sentiment, although the market staged a modest rebound after investors viewed much of the negative news as already priced in.
