AmPRS – Conservative Fund (the "Fund") aims to preserve* capital by investing primarily in fixed income securities and money market instruments.

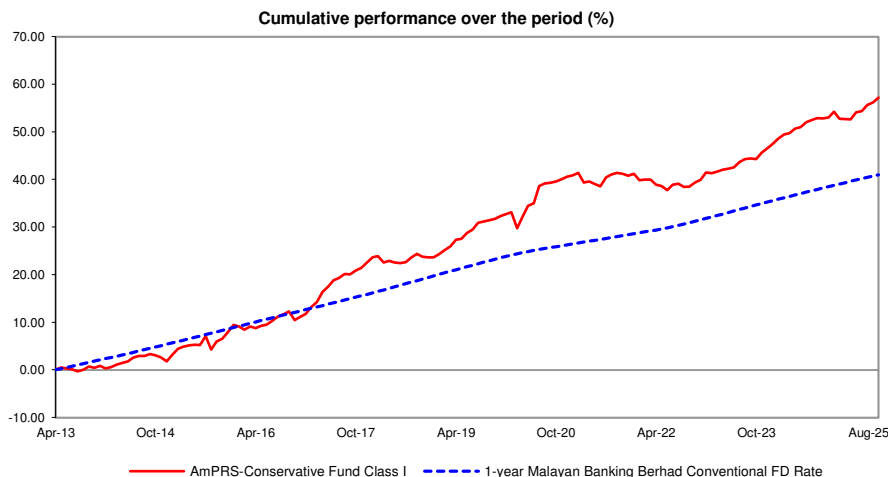
The Fund is suitable for Members who seek:

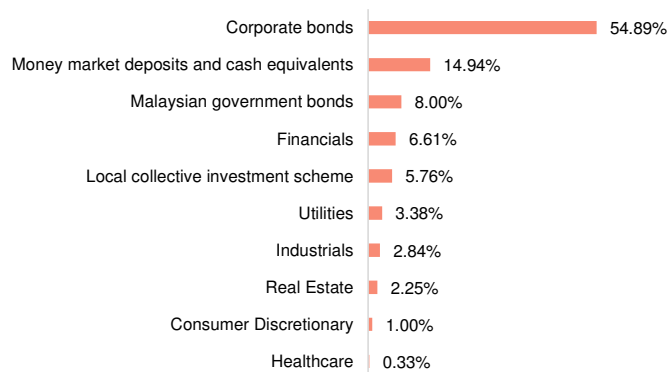

Sector Allocation (as at 31 August 2025)



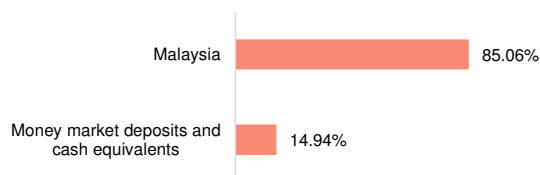

PRS Provider's Commentary (as at 31 August 2025)

Malaysia's 2Q25 GDP growth held steady at 4.4% YoY, supported by front loading activity, due to pause on higher tariff rates. As the US reciprocal tariff of 19% has been announced on imports from Malaysia, domestic growth could be slower ahead as external demands weaken.

We maintain overweight on duration, given the supportive background. Yield curve positioning strategy is deployed at the belly of the curve (5–7 years) to capture potential curve flattening and benefit from bonds "rolling down" to lower yields.

We prefer corporate bonds for higher yield pick-up, compared to govies. Credit spreads are likely to stay tight, with strong demands from local investors. We are selective on credit names, with a focus on defensive sectors and issuers with strong credit metrics, particularly in utilities, infrastructure, and banks.
