Investment Objective

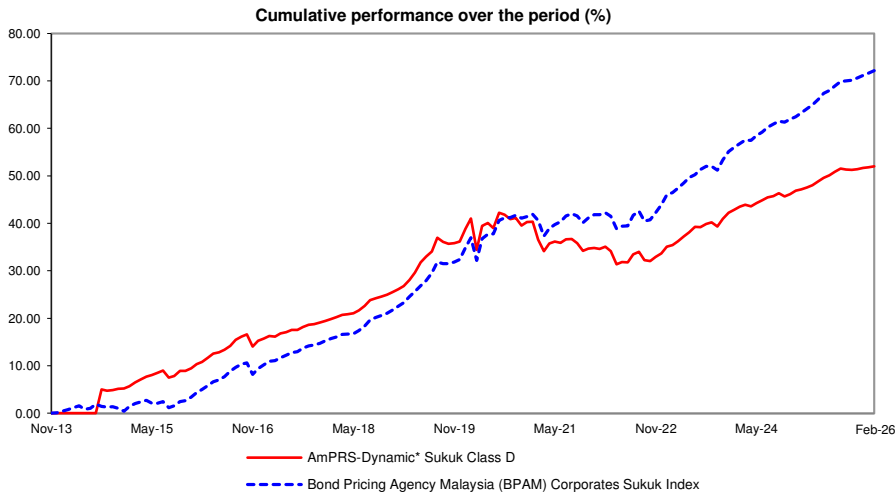
AmPRS – Dynamic* Sukuk (the "Fund") aims to provide capital appreciation by investing in the AmDynamic* Sukuk.
*The word "Dynamic" in this context refers to the Target Fund's investment strategy which is active management, not buy-and-hold strategy.

The Fund is suitable for Members who:

- seek steady growth in value by investing in Sukuk as an asset class; and
- are willing to assume additional interest rate risk, duration risk and liquidity risk associated with investing in Sukuk with long duration (i.e. there will be no portfolio maturity limitation) and low credit ratings (i.e. there will be no minimum rating for Sukuk purchased or held by the Target Fund).

Note: Any material change to the investment objective of the Fund would require Unit Holders' approval.

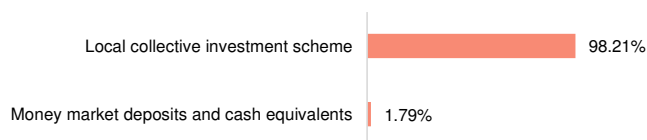

Asset Allocation (as at 28 February 2026)



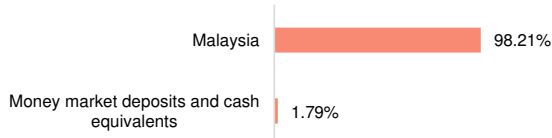

PRS Provider's Commentary (as at 28 February 2026)

Geopolitical tensions have sharply intensified following large-scale U.S.–Israeli military operations against Iran, triggering a pronounced risk-off sentiment across global markets. The heightened uncertainty has pushed investors globally toward safe-haven assets, increasing volatility in emerging-market fixed income and weakening regional currencies, including the ringgit.

Against this backdrop, Malaysia's corporate bond market is poised for a period of heavier supply, with 2026 issuance expected to reach RM130–140 billion—well above the long-term average. This increase in upcoming supply, combined with heightened geopolitical uncertainty, may trigger investors to stay defensive in the near term.

However, rising yields amid current volatility may create compelling opportunities for medium- to long-term investors. Malaysia's resilient fixed-income fundamentals and stable macro backdrop continue to underpin the attractiveness of ringgit-denominated assets, offering potential entry points as valuations become more appealing.

We maintain slight overweight on the portfolio duration and prefer belly of the curve (5- to 7-years) for carry and roll-down yield. Meanwhile we prefer high quality corporate bond/sukuk over govvnies now and maintain short term liquidity for trading purpose.
