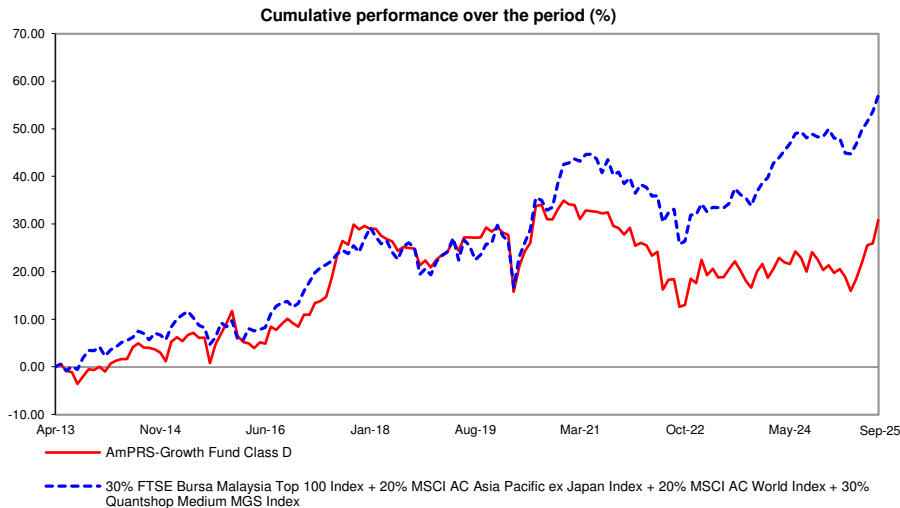
The Fund is suitable for Members who seek:

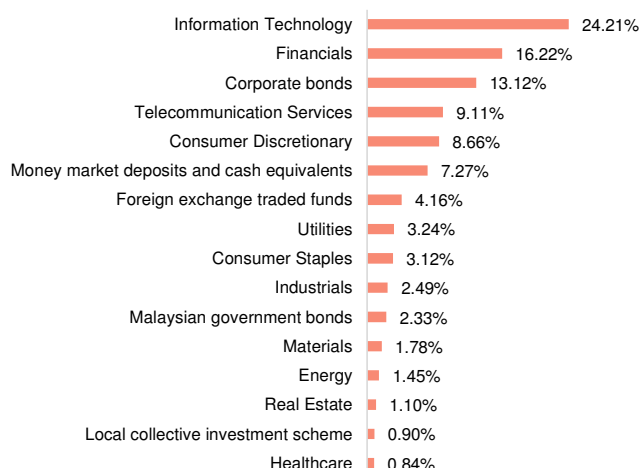

Sector Allocation (as at 30 September 2025)



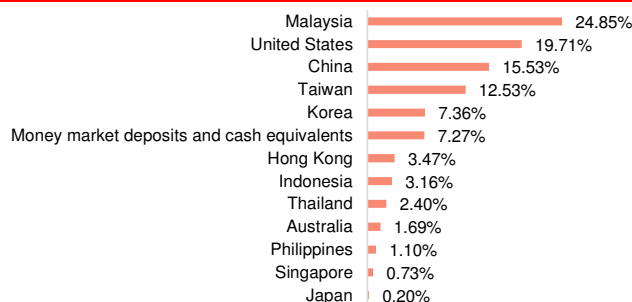

PRS Provider's Commentary (as at 30 September 2025)

Global equity markets continued their upward trend in September, as investors moved past concerns over a potential U.S. government shutdown and experienced an unusually strong month. Additionally, the Federal Reserve implemented a long-awaited 25 basis point ("bps") rate cut, lowering the Federal Funds Rate ("FFR") to 4.00–4.25%. This move helped to boost investor risk appetite. North Asian markets, particularly Taiwan and South Korea, benefited from significant technology Capex announcements. In contrast, ASEAN markets were mixed. Preference remains tilted toward domestic demand-driven and high-yielding sectors, amid ongoing concerns about a global trade slowdown.
