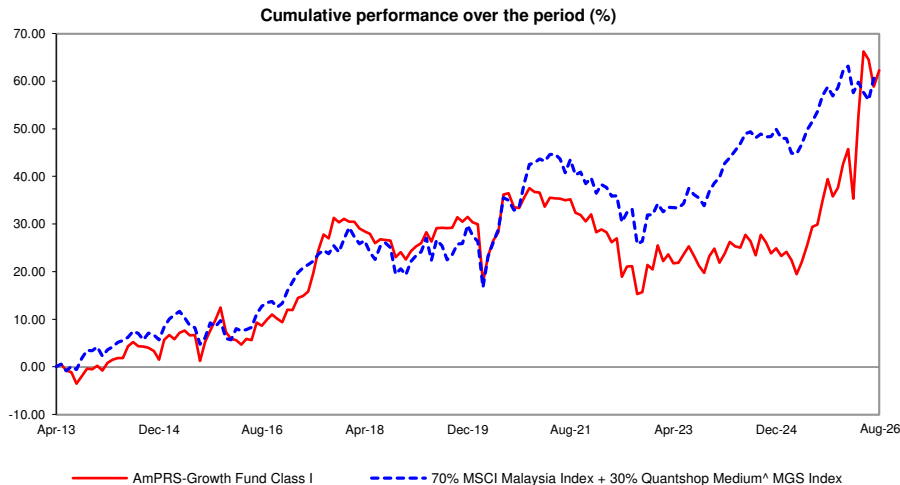
The Fund is suitable for Members who seek:

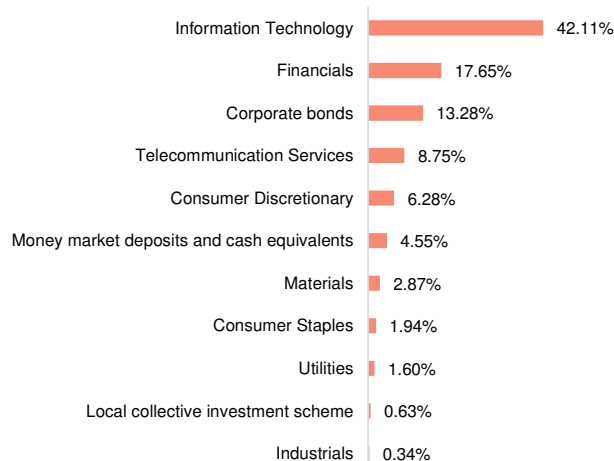

Sector Allocation (as at 31 August 2026)



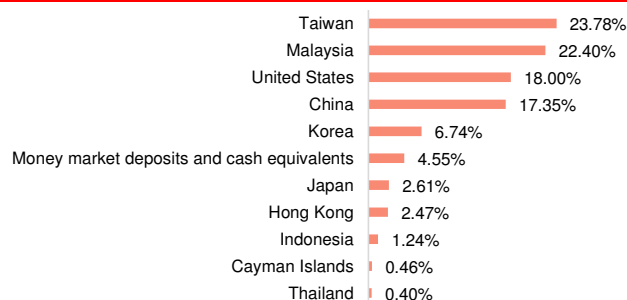

PRS Provider's Commentary (as at 31 August 2026)

Global markets recovered in August, with the Magnificent Seven reporting strong earnings growth of 118.5% in 2Q 2026. Robust corporate earnings benefited Asia-Pacific markets, particularly Korea and Taiwan, due to their semiconductor exports. However, the Indian and Hong Kong markets declined amid rising crude oil prices and a tighter global liquidity environment. ASEAN markets, meanwhile, remained mixed, with Indonesia and Singapore outperforming their regional peers. Amid the volatility, we remain selective, favouring quality companies with strong structural growth prospects and attractive dividend yields.
