Investment Objective

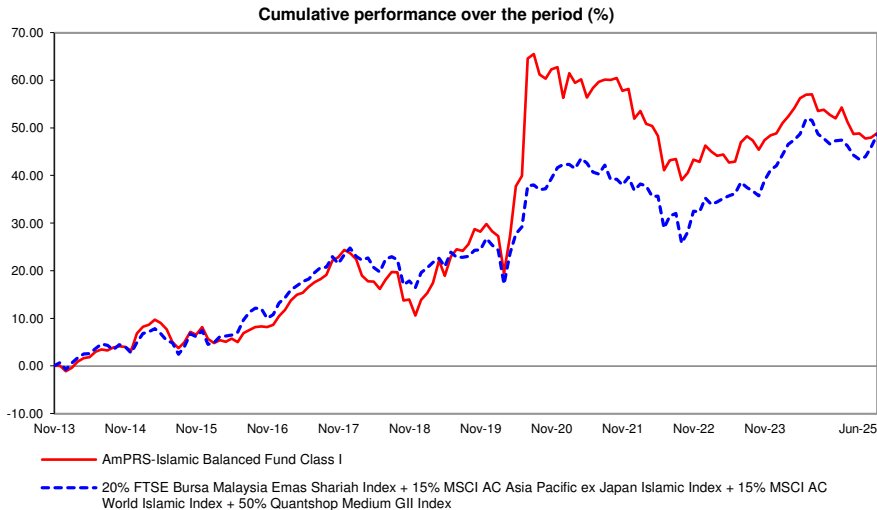

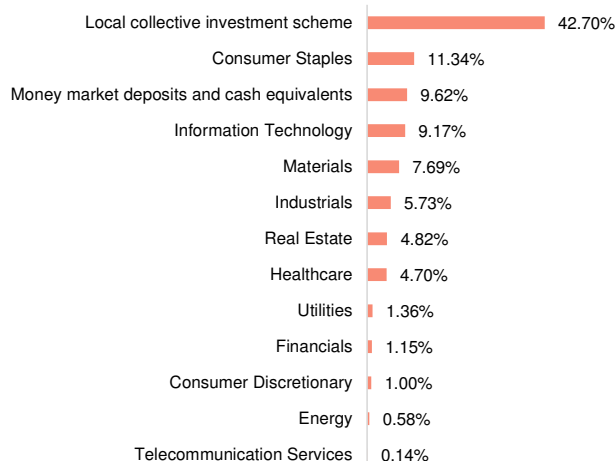

Sector Allocation (as at 30 June 2025)



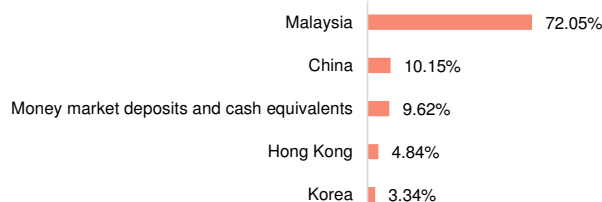

PRS Provider's Commentary (as at 30 June 2025)

Global equities rose in July on trade progress and easing tensions. China gained from policy-driven growth; Hong Kong from low HIBOR and crypto laws. Korea rallied on reforms and tech momentum, Taiwan rallied on Taiwanese Dollar rise and tech led growth, while India saw gains from rate cuts and easing inflation. Despite high valuations, especially in the US, Asia equities remain favored on stable inflation, strong tech, and currency strength. However, trade risks and strong regional currencies may pose export challenges. Preference remains for domestic demand-led and high-yielding sectors amid global trade slowdown concerns.
