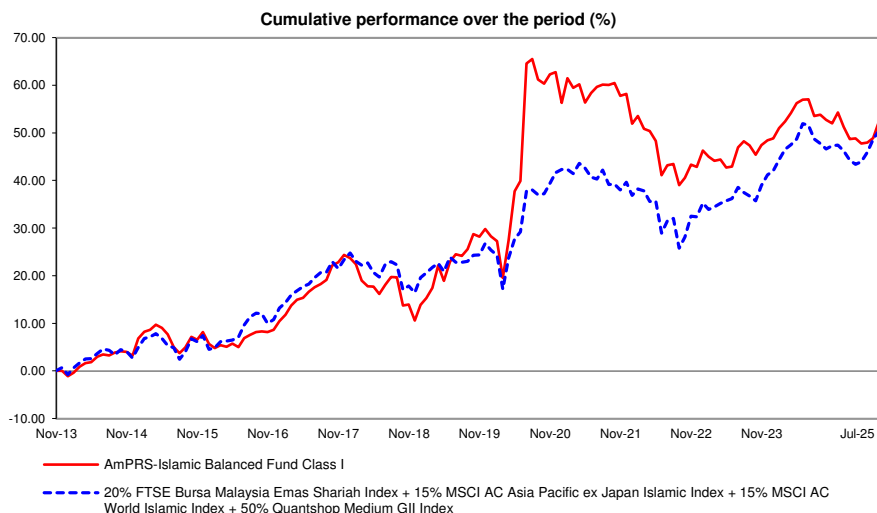

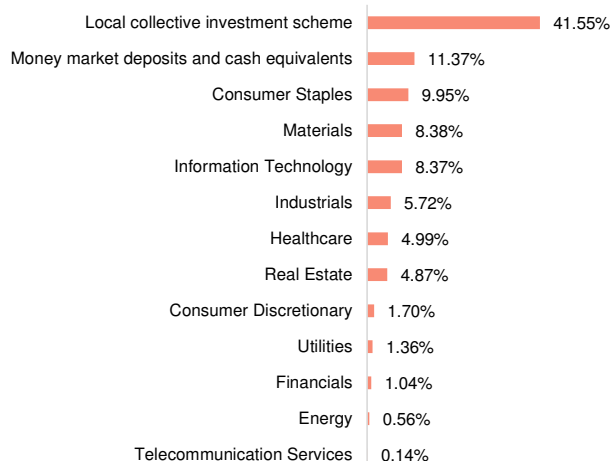

Sector Allocation (as at 31 July 2025)



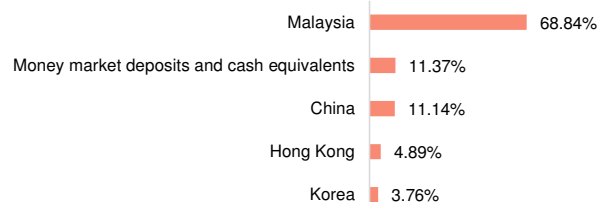

PRS Provider's Commentary (as at 31 July 2025)

Global equities rose in July on more trade deals being reached and better earnings. China gained on strong GDP growth and expanded policy support both on the supply side (anti-involution policy) and the demand side (mega hydropower project). Hong Kong gained on continued US-China trade talks, solid southbound inflows on biotech's out-licensing deals and anti-involution policy lifting prices. Korea rallied on reforms and tech momentum. Taiwan rose on continued AI momentum. India corrected on sluggish earnings and tariffs uncertainties. As more trade deals reached removing uncertainties, Asia equities remain favored on stable inflation, strong tech, and currency strength. Preference remains for domestic demand-led and high-yielding sectors amid global trade slowdown concerns.
