Investment Objective

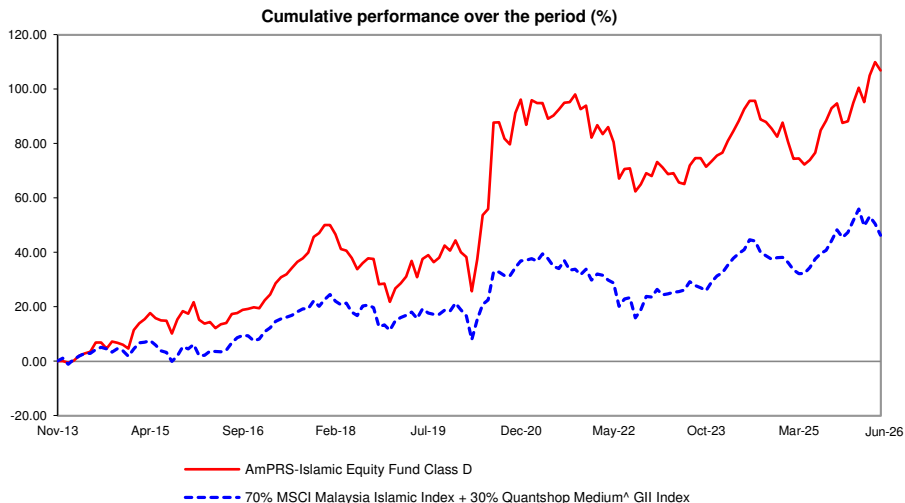

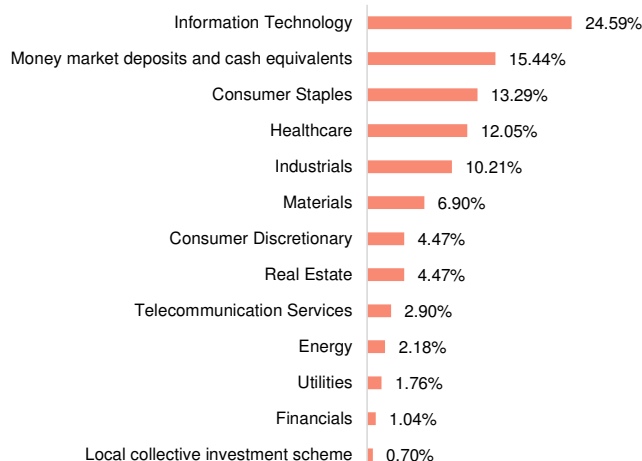

Sector Allocation (as at 30 June 2026)



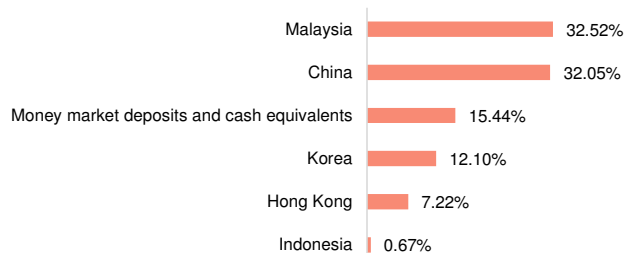

PRS Provider's Commentary (as at 30 June 2026)

Global equities were mixed in June as profit taking in AI and mega-cap technology stocks drove rotation into industrials, value and cyclical sectors, supported by resilient economic data and a more hawkish Fed. China A-shares advanced on ample liquidity, while the HSI lagged amid growing divergence between onshore and offshore markets and AI versus non-AI segments. Korea was volatile despite a flat market, with long-term investment commitments in semiconductors, AI and data centres underpinning structural growth. Taiwan extended AI-driven gains, while India rebounded on easing geopolitical tensions and lower oil prices. We remain selective, favouring quality companies with structural growth, domestic demand support and attractive yields while maintaining a prudent risk stance.
