Investment Objective

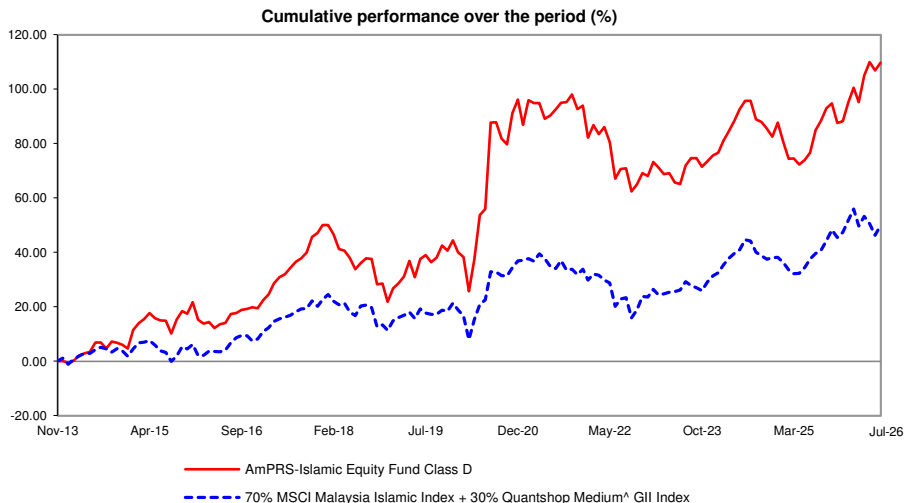

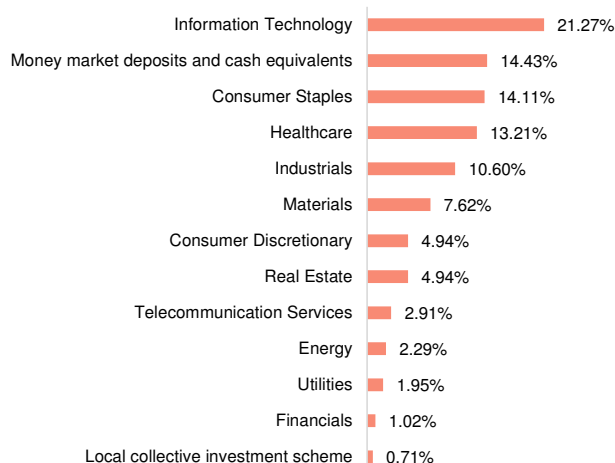

Sector Allocation (as at 31 July 2026)



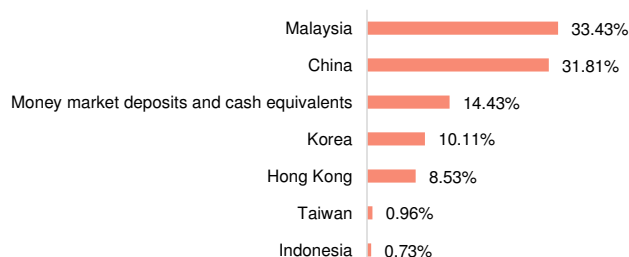

PRS Provider's Commentary (as at 31 July 2026)

Asian equities were mixed in July. Global markets softened as profit-taking in AI and mega-cap technology names, rising Treasury yields and mixed earnings prompted rotation into industrials, defensives and value stocks. China A-shares declined amid an unwind of crowded AI trades, while offshore internet stocks outperformed on short covering and policy optimism. Korea and Taiwan corrected sharply as AI-related positions unwound, amplified in Korea by leveraged ETF flows and hedge fund de-risking. India outperformed, supported by earnings resilience, positive macro indicators and rotation flows. We remain selective, favouring quality companies with structural growth and attractive yields.
