Investment Objective

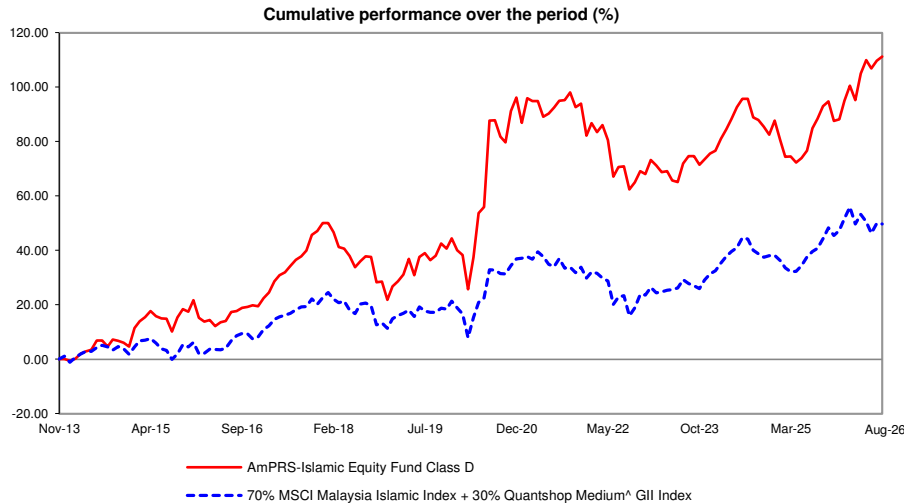

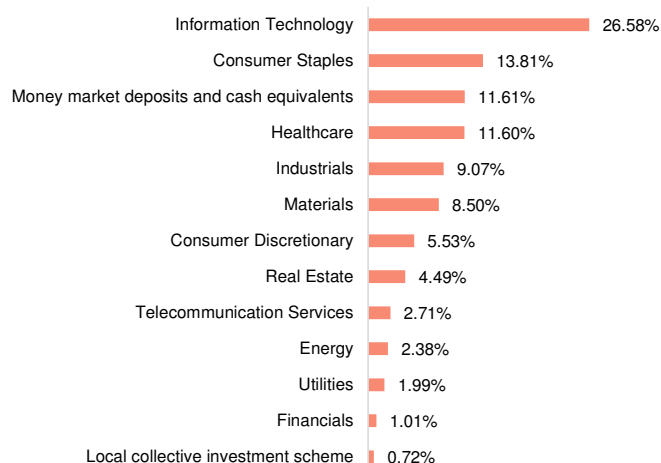

Sector Allocation (as at 31 August 2026)



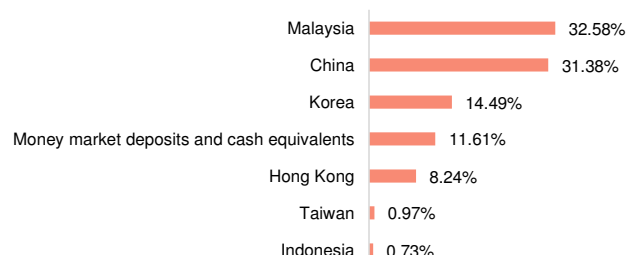

PRS Provider's Commentary (as at 31 August 2026)

US equities led global gains in August on strong Q2 earnings and AI enthusiasm, though Fed Chair Warsh's hawkish Jackson Hole remarks pushed 10-year yields to 4.75%. Asian markets diverged: TAIEX surged 7.0% and KOSPI rose 3.4% on AI and tech recovery; CSI 300 edged up 0.8% as A-Shares recovered slightly from the deleveraging in July; Hang Seng fell 1.2% on rising yields and tighter liquidity. India's SENSEX declined 1.5%, dragged by oil prices, IT weakness and heavy constituent selloffs. We remain selective, favouring quality companies with structural growth drivers, resilient earnings and attractive yields.
