Investment Objective

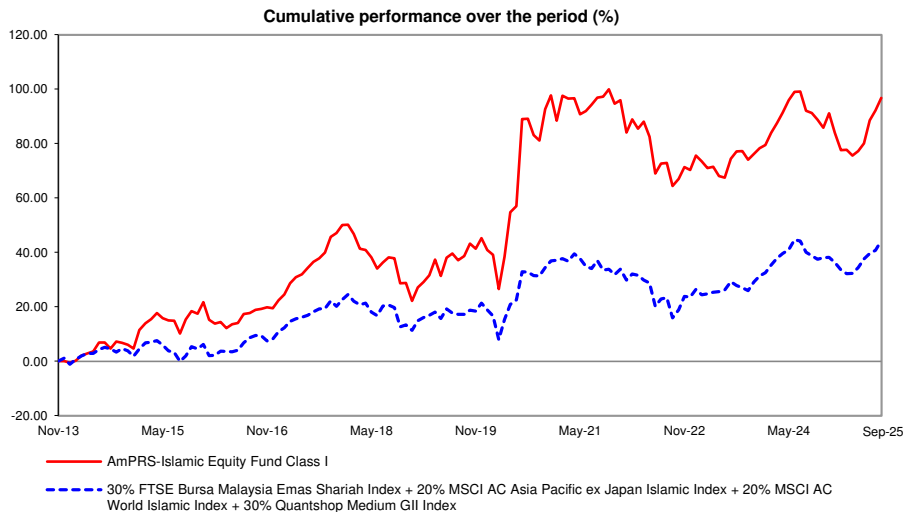

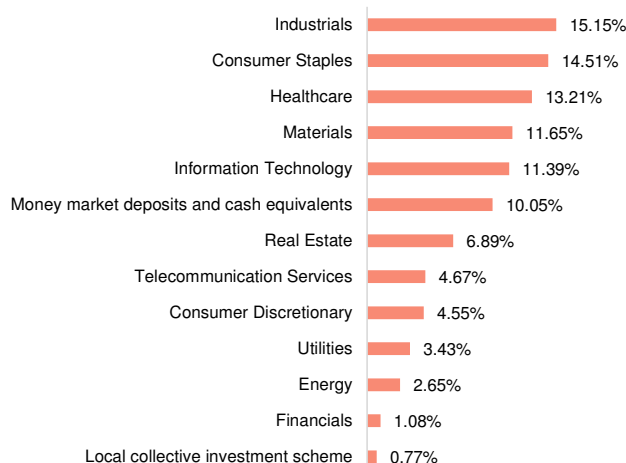

Sector Allocation (as at 30 September 2025)



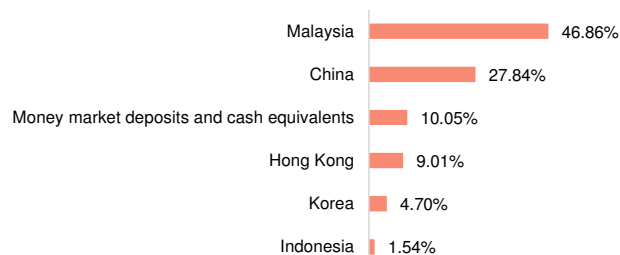

Global equities rose in September, driven by easing US shutdown fears and AI optimism. China and Hong Kong gained on improving US-China ties and policy expectations ver the 4th Plenum on 20-23 October and the Central Economic Work Conference in early December. Korea and Taiwan rallied on strong tech capex and memory prices. India followed regional sentiment. Compared to high US valuations, Asia remains attractive due to stable inflation, tech strength, and return of foreign inflows. Preference leans toward domestic demand-led and high-yield sectors amid global trade slowdown concerns.
