Investment Objective

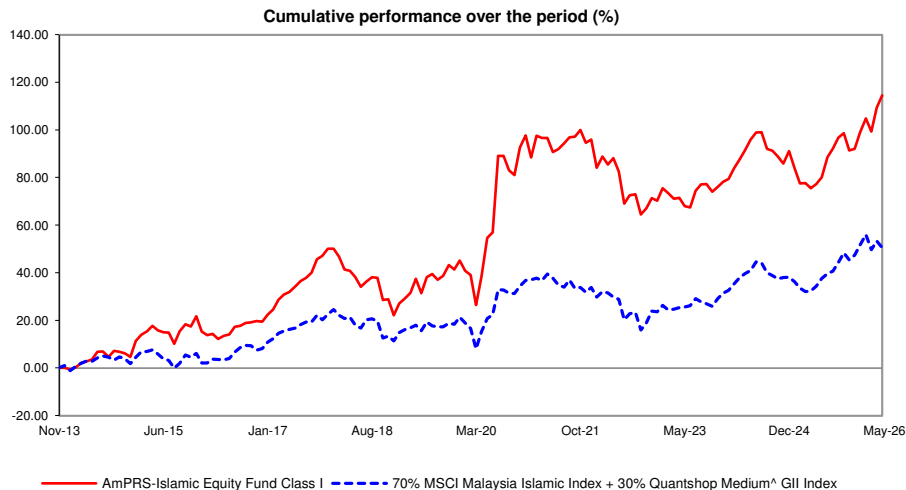

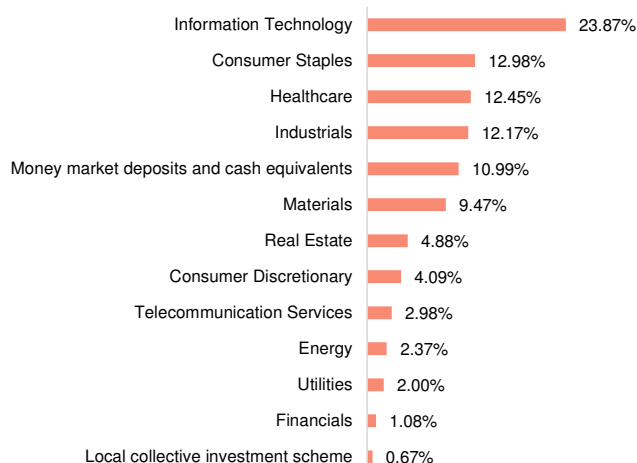

Sector Allocation (as at 31 May 2026)



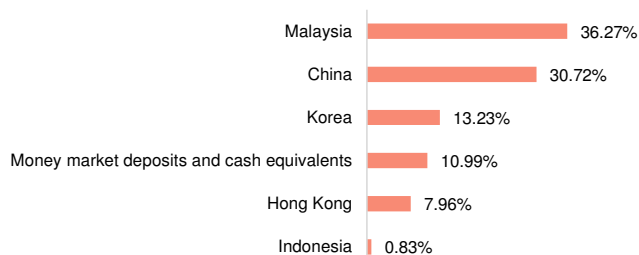

PRS Provider's Commentary (as at 31 May 2026)

Global equities advanced in May, supported by AI-driven sentiment. China A-shares rose on ample liquidity, while HSI weakened amid softer risk appetite and limited traction in platform internet, constrained by uncertain AI monetization, mixed 1Q earnings and intensifying competition. Korea and Taiwan extended gains on AI momentum. India declined on tech sector obsolescence concerns, though materials held up on precious metals tax support. We remain cautious, focusing on selective stock picking, lower beta exposure, and sectors with structural growth, domestic demand and attractive yields.
