AmPRS – Moderate Fund (the "Fund") aims to provide medium to long term capital growth by investing in equities, fixed income securities and/or REITs.

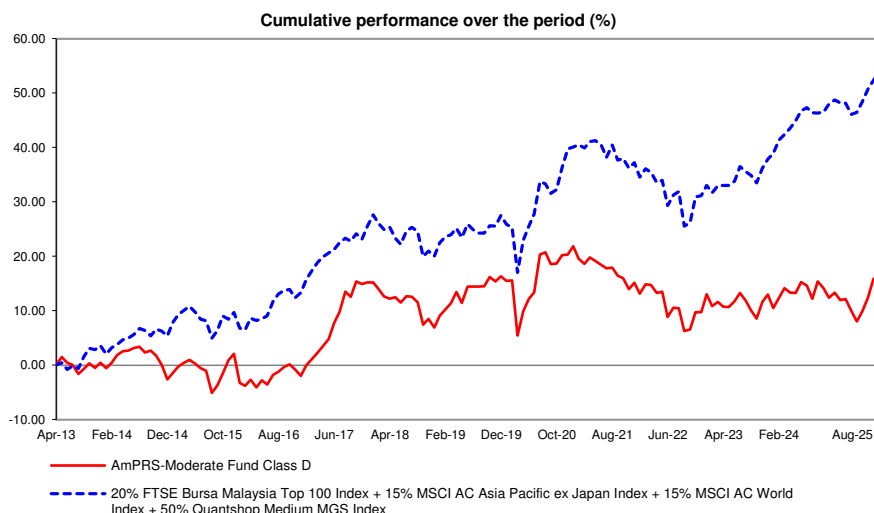
The Fund is suitable for Members who seek:

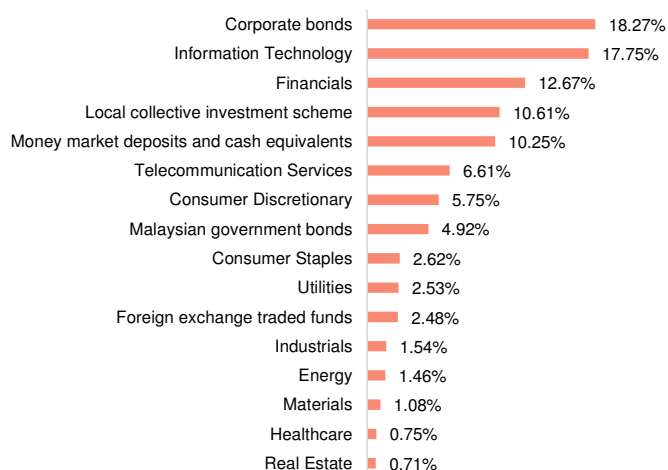

Sector Allocation (as at 31 August 2025)



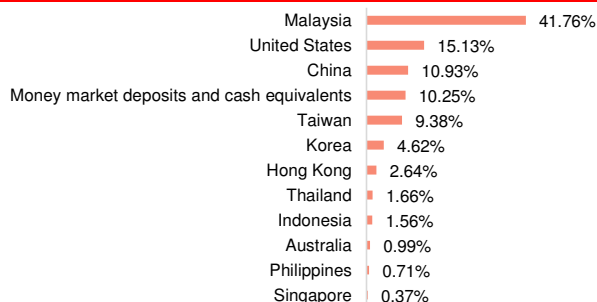

PRS Provider's Commentary (as at 31 August 2025)

Global equities rose in August on strong earnings reports and optimism around AI. China and Hong Kong gained on improving liquidity amid higher market turnover, coupled with optimism over extended US-China tariff pause to Nov 10th and anti-involution. Korea retreated first time after 5 months rally amid uncertainty on the governance reform momentum, while Taiwan rose on continued AI momentum. India corrected on additional tariff implementation by the US, persistent foreign investors' selling and weak INR. As overhang on tariff negotiations uncertainty coming to the end, Asia equities remain favorable on stable inflation, strong tech, and currency strength. Preference remains for domestic demand-led and high-yielding sectors amid global trade slowdown concerns.
