AmPRS – Moderate Fund (the "Fund") aims to provide medium to long term capital growth by investing in equities, fixed income securities and/or REITs.

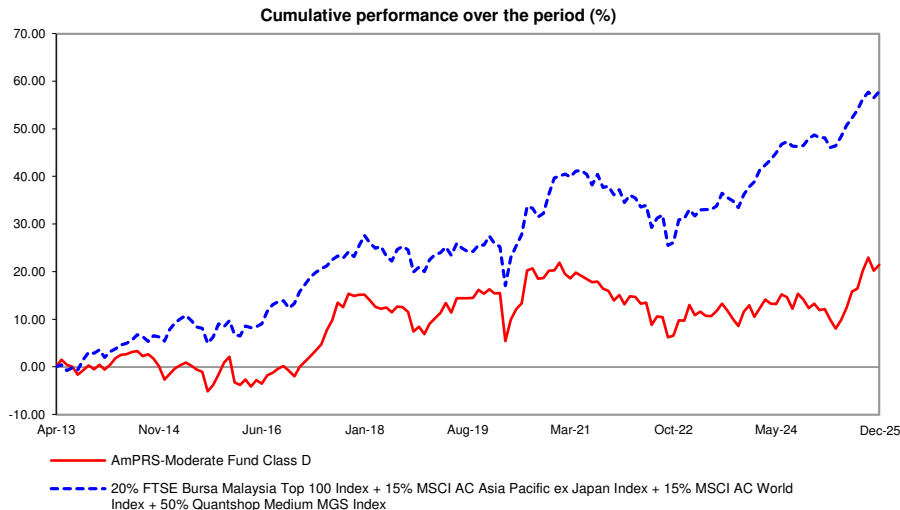
The Fund is suitable for Members who seek:

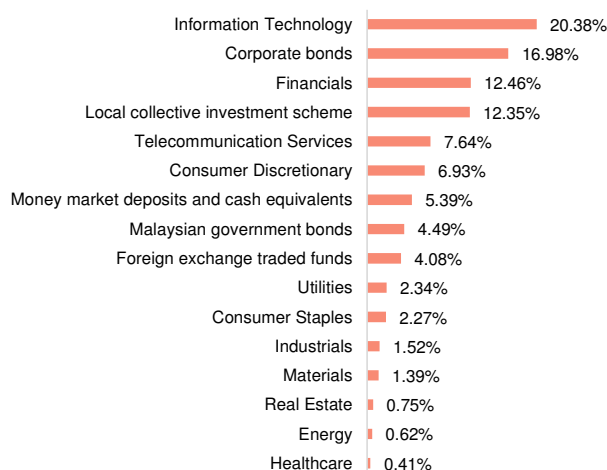

Sector Allocation (as at 31 December 2025)



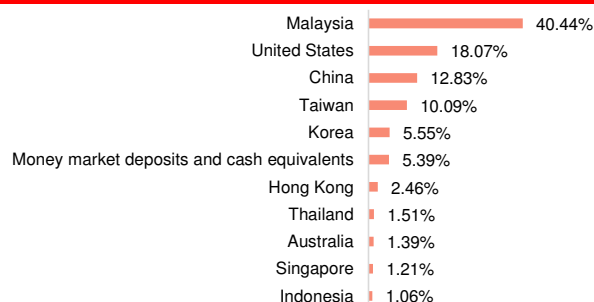

PRS Provider's Commentary (as at 31 December 2025)

Global equities were mixed in December. U.S. markets edged marginally lower, while Asia Pacific rebounded from November's decline. Chinese equities rose on positive sentiment after the Central Economic Work Conference, while Korea and Taiwan gained on tech strength. Indian equities, meanwhile, fell on INR weakness and stalled trade talks with the U.S. ASEAN markets advanced, led by Vietnam and Malaysia. Looking ahead, expected U.S. rate cuts should support foreign inflows into emerging markets. We remain cautiously optimistic, favoring sectors driven by domestic demand and high-yield stocks for resilience amid external volatility.
