AmPRS - Moderate Fund (the "Fund") aims to provide medium to long term capital growth by investing in equities, fixed income securities and/or REITs.


The Fund is suitable for Members who seek:



PRS Provider's Commentary (as at 30 November 2025)

Global equities broadly declined in November, weighed down by concerns over a potential Al-driven market bubble. Korea, Taiwan, and China saw corrections following strong October gains, as profit-taking combined with uncertainty around U.S. Federal Reserve rate policy and cautious forward guidance from technology firms. In contrast, India outperformed on optimism surrounding a U.S. trade deal and robust 3Q25 GDP growth. ASEAN markets were mixed. Looking ahead, anticipated U.S. rate cuts are expected to support foreign inflows into emerging markets. We continue to favor sectors driven by domestic demand and high-yielding stocks, which offer resilience amid external volatility.
