AmPRS – Moderate Fund (the "Fund") aims to provide medium to long term capital growth by investing in equities, fixed income securities and/or REITs.

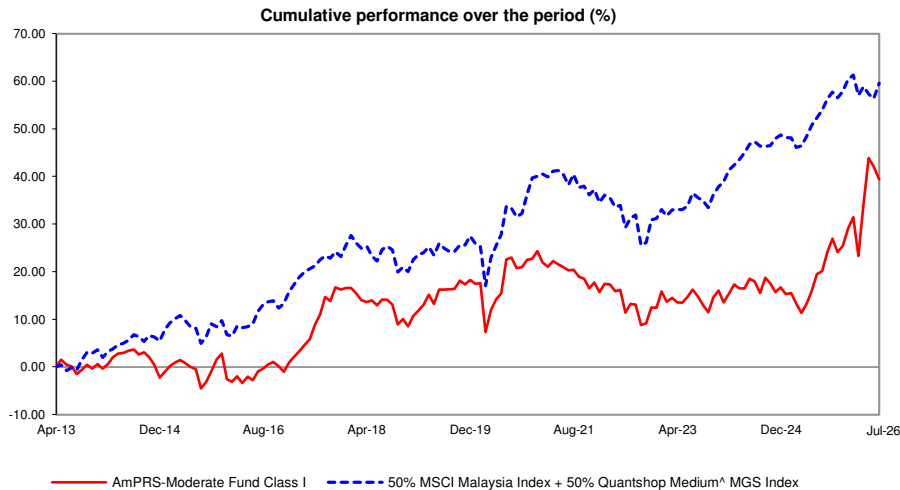
The Fund is suitable for Members who seek:

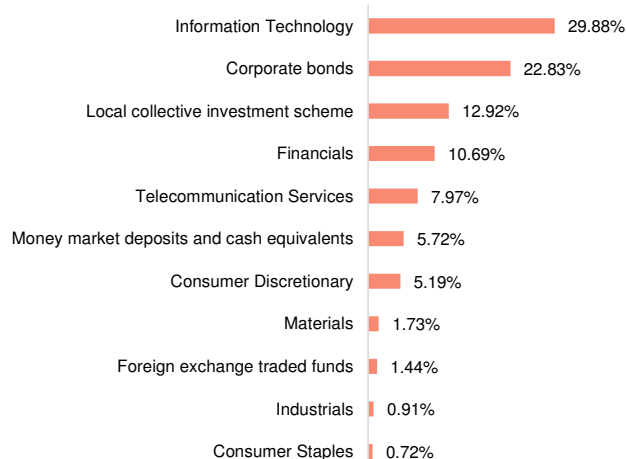

Sector Allocation (as at 31 July 2026)



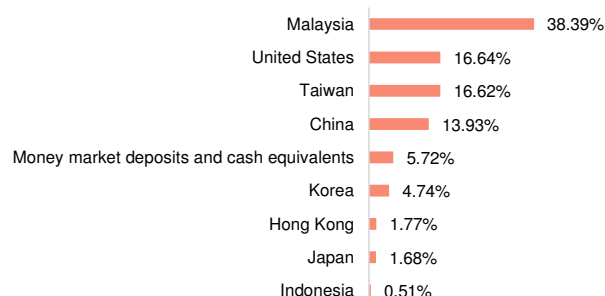

PRS Provider's Commentary (as at 31 July 2026)

Global markets were mixed in July, with profit-taking in AI and mega-cap technology stocks prompting a rotation into industrials and defensive sectors. China A-shares declined amid the unwinding of crowded AI trades, while offshore internet stocks outperformed on policy optimism. Korea and Taiwan corrected as AI-related positions were unwound, with the decline in Korea amplified by leveraged ETF flows and hedge fund de-risking. India outperformed, supported by resilient earnings, positive macroeconomic indicators, and rotation-driven inflows. We remain selective, favouring quality companies with structural growth prospects and attractive dividend yields.
