- participation in the global equity market.

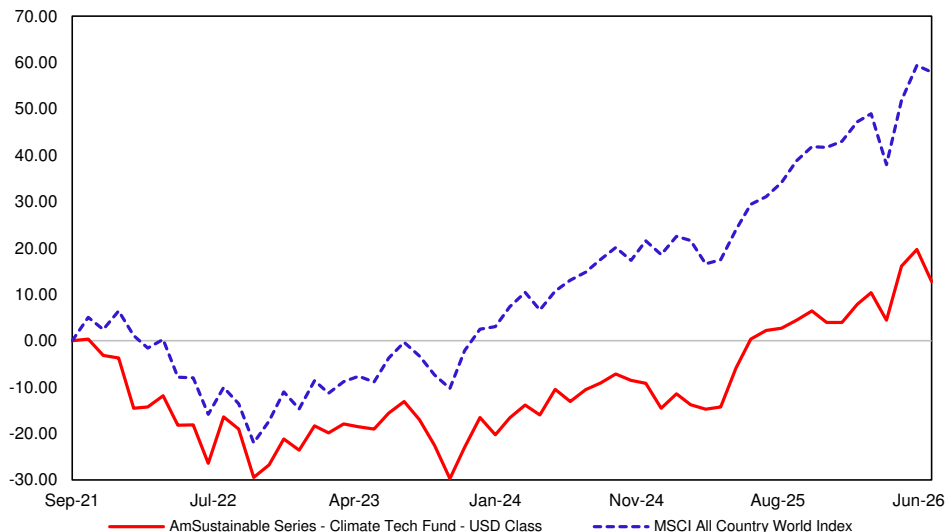

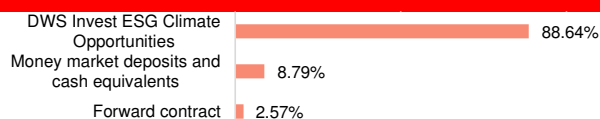

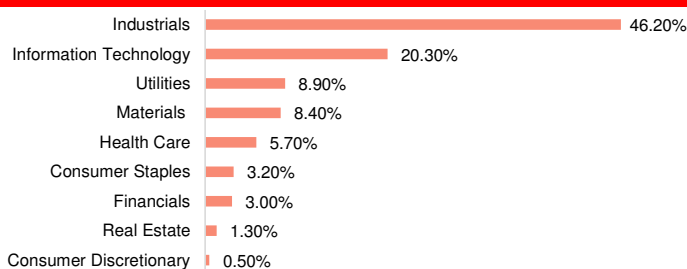

Target Fund's Sector Allocation* (as at 30 June 2026)

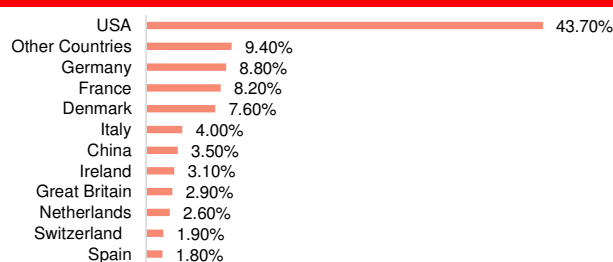

Target Fund Manager's Commentary (as at 30 June 2026)

After strong gains in previous months, global equities eased slightly in June amid heightened volatility but still finished Q2 firmly positive. Investors focused on central bank decisions, with the ECB and BoJ both raising rates by 25bps, while the Fed left rates unchanged but maintained a hawkish stance. The stronger US dollar and a sharp decline in oil prices following the US-Iran agreement on the Strait of Hormuz also shaped markets. Meanwhile, Elon Musk's space venture completed the largest IPO on record. European heatwaves in June (with temperatures up to ~40–44°C across France, Germany, Spain and the UK) significantly stressed power systems. Cooling demand rose by up to ~10–15%, while nuclear output in France and Switzerland was curtailed due to elevated river temperatures and hydropower weakened by drought. Evening power prices spiked sharply in the day-ahead market (up to €600–1,000/MWh) as solar generation faded, underscoring the growing need for storage and flexibility solutions. Sadly, such extreme weather events did come along with heat related mortality (incl. reported fatalities in France). In addition, latest data show that the natural disaster insurance gap topped \$424bn as uninsured losses rose by 7% globally in 2025. Both data points reinforce the urgency of climate adaptation strategies with global spending on grid resilience, disaster prevention and water management expected to reach \$20 trillion over the next decade according to Bloomberg intelligence Global equity markets delivered mixed performance in June. The S&P 500 declined 1.0%, while the technology-heavy NASDAQ was broadly flat (in USD). In Europe, the MSCI Europe gained 3.1%, although Germany's DAX fell 0.4%. Japan's TOPIX advanced 1.1%, while emerging markets underperformed, with the MSCI Emerging Markets Index declining 1.4% (in USD). Sector performance was led by industrials, healthcare and financials, while communication services, energy and consumer discretionary stocks lagged.

The strong performance of clean tech equities is not merely cyclical, but reflects a structural shift in the global energy and economic landscape. Geopolitical tensions and recurring supply shocks have once again elevated energy security to a top political and economic priority. Across Europe and Asia, the expansion of domestic renewable energy capacity is increasingly viewed less as a climate policy tool and more as a key pillar of economic resilience, supply security and geopolitical sovereignty. Structural demand drivers remain firmly intact. Electricity demand is rising sharply, driven by data center and AI infrastructure expansion, electrification of transport and industry, and ongoing reshoring of manufacturing. Power grids are already operating near capacity in many regions, resulting in higher congestion costs, renewable curtailments and greater price volatility. This underscores the urgent need for sustained investment across the entire power value chain from generation and transmission to distribution networks, transformers, power electronics, storage and monitoring software. Renewables continue to benefit from both economic and strategic advantages. Utility-scale solar and wind remain among the fastest and most cost-effective sources of new power generation globally, while hyperscalers' willingness to pay premium prices for clean, firm capacity further strengthens project economics. Energy storage is increasingly emerging as a critical system enabler, supporting grid stability, load shifting and security of supply. Technological innovation continues to accelerate adoption. Advances in battery chemistry, charging speeds and system integration are improving the economics of electric vehicles, stationary storage and distributed energy solutions. While valuations have recovered from their 2024 troughs, we believe this is underpinned by high order visibility, scaling benefits and improving cost structures, supporting solid earnings momentum across the sector.
