# **AmGlobal Property Equities Fund** (formerly known as Global Property Equities)



### **Fund Overview**

### Investment Objective

AmGlobal Property Equities Fund (formerly known as Global Property Equities) (the "Fund") seeks to provide investors with longterm capital appreciation by investing in the quoted equity securities of companies or REITs (or its equivalent) listed or traded on regulated markets which derive the main part of their revenue from the ownership, management and/or development of real estate, throughout the world. The Fund is denominated in RM.

### The Fund is suitable for investors:

- · seeking potential income\* and growth through exposure to global property related securities; and
- seeking potential long-term\*\* capital appreciation through global market.

Note: \*The income could be in the form of units or cash

"Long-term refers to a period of at least five (5) years.

Any material change to the investment objective of the Fund would require Unit Holders' approval.



Global listed real estate made gains in September but lagged equities, as mega-cap technology stocks fuelled US gains amid an artificial intelligence (AI)-driven boom. The US Federal Reserve (Fed) cut rates by 0.25% (to 4.00-4.25%), and projected further easing later in the year. Global REITs saw modest gains over the month following a strong August. Within US REITs, malls and healthcare outperformed, while single family rentals, apartments, hotels and towers all lagged. Encouragingly, financing conditions for REITs notably improved over the month, with many accessing the bond markets as investment-grade REIT credit spreads tightened to 25-year lows. In Asia Pacific, Japan outperformed as the Bank of Japan's ultra-easy policy continues to support Japan's property market, while Australia lagged. It was another muted month for European real estate. The UK, France and Switzerland outperformed, although German residential landlords trailed, along with continental logistics/industrial and cell towers.

Target Fund Manager's Commentary (as at 30 September 2025)

US residential landlords American Homes 4 Rent and UDR were notable detractors over the month as residential rent growth data lagged expectations through the peak spring/summer leasing season. This was partially offset by positive contributions from medical and healthcare landlords Healthcare Realty and Ventas, as well as data centre owner Digital Realty Trust. We closed the position in Japanese hotel landlord Invincible Investments and opened a new small position in Centurion Accommodation via its initial public offering (IPO) in Singapore. We also took the opportunity to top up positions in holdings that have recently lagged against a more 'risk on' market, adding to Stockland, Welltower, Equinix, Public Storage, American Homes 4 Rent and retail net lease landlord Netstreit.

While the macroeconomic outlook remains uncertain, property fundamentals remain healthy across most real estate sectors. Demand for high-quality space remains resilient, which, combined with falling new supply is translating into stronger pricing power for many of the landlords in which we invest. Asset prices have reset in recent years and we expect falling interest rates to be supportive for values from here. We expect public REITs to continue to lead the recovery in real estate markets, boosted by more exposure to winning real estate sectors, lower leverage, and a cost and access to capital advantage providing a pathway for growth. Importantly, public REITs have continued to offer reliable and growing income streams, a characteristic which should continue to reward investors in our view.
